Summary of Public Hearing IL 47: Kennedy Road in Yorkville to Cross Street in Sugar Grove

A public hearing was held on May 30, 2018 at the Sugar Grove Township Community Building. The purpose of the hearing was to present proposed project information and potential impacts and to answer project questions and receive public comments. The hearing was announced by advertisement in local newspapers, through local agencies, through the IDOT website and through invitational letters sent to local officials, legislators, advisory groups, parties showing interest in the project and to those owning property along the study length of IL 47. Seventy-seven individuals signed in at the hearing including one newspaper reporter, one radio station reporter, and various local agency representatives from townships, Villages, and Counties. Representatives of IDOT District 1, IDOT District 3 and the consultant engineering firm Lochner were present but are not included in the attendance total.

The meeting's display materials included aerial exhibits depicting the preferred alternative, the project purpose and need, typical sections, a summary of anticipated environmental impacts, maps of the project area, project traffic data, the Rob Roy Creek floodplain and five years of crash data.

The comment period ended on June 13, 2018. A total of sixteen comment sheets were received during the hearing along with one tape recorded comment that reiterated a comment sheet received. A total of 34 comments were received by the end of the comment period. The table below provides a synopsis of the written comments that were received. One noise barrier viewpoint ballot was received during the hearing. Additional comments included with noise ballots received during the comment period were made part of the hearing record and included in the summary.
