Job Responsibilities

- 1. Operates CDL Class A or B licensed vehicles.
 - Operates maintenance trucks, tractors, snowplows, salt spreaders, compressors, jack hammers and other highway equipment for the use of maintaining and snow plowing during the winter season.
 - Operates wheel loaders, backhoe loaders, rollers, excavators, road graders and cranes in repairing, replacing or patching concrete.
 - Assists in servicing, washing and making minor repairs of equipment such as trucks, tractors, mowing machines, snowplows, salt spreaders, compressors, graders and other light highway equipment.
