 - Conducts follow-up research for the Land Acquisition Engineer regarding program impact and operation and advises of any further actions that may be necessary.
 - Processes condemnations by Eminent Domain involving special legal actions through staff, the SMG's and Attorney General, which requires preparation of sensitive legal and technical documents at the proper time to meet court dates for quick-takes.
 - Assists in compiling Certification of Federal Aid Participation projects.
 - Coordinates workflow to and from the Land Acquisition Engineer's office verifying the timely completion of functions, advises bureau chief of concerns and notifies staff of changes and or revisions.
