1. As Lead Worker, outlines and directs work activities of skilled and unskilled workers of the Bridge Maintenance crew involved in the performance of bridge deck patching, minor structural repair, traffic control, maintenance of rights-of-way and snow and ice removal.

- Determines assignments and lays out work.
- Provides verbal and written guidance and direction to staff in the completion of duties.
- Directs the activities of personnel to ensure conformance with departmental policies and procedures.
- Advises immediate supervisor regarding performance of assigned staff.

2. Performs labor relating to maintenance and repair of bridge deck patching, minor structural repair, traffic control, maintenance of rights-of-way and snow and ice removal.

- Performs maintenance and repair of road surfaces and deck patching, traffic control and maintenance of rights-of-way.
- Operates Commercial Driver's License (CDL) Class A licensed vehicles including maintenance trucks, tractors, snowplows, salt spreaders and other equipment including compressors, jack hammers and generators.
- Responds to emergency weather situations, as instructed verbally or in writing, to inspect roadways and remove hazardous material/obstacles, some weighing up to 50 pounds, from roadways and drainage areas.

3. Prepares and submits daily report for hours worked, supplies used, and work performed. Verifies records of employees' overtime and other records as required.

4. Participates in conjunction with the Bridge Operations Supervisor in laying out jobs and adjusting crew and personnel assignments.

5. Instructs personnel verbally and in writing in the proper care, maintenance and safe use of equipment in accordance with the departmental safety code and operating instructions.

6. During snow and ice conditions, assists in snow and ice control.

- Operates snowplows, spreads salt and sand .
- Plows and removes snow.
- Prepares road condition reports.

7. Performs other duties as required or assigned which are reasonably within the scope of those enumerated above.

## **Knowledge, Skills, and Abilities**

### **Minimum Qualifications**

1. Requires knowledge, skill and mental development equivalent to the completion of two years of high school.
2. Requires two years of experience performing highway construction and maintenance work.

### **Conditions of Employment**

1. Requires successful completion of a background investigation.
2. Requires possession of a Class A CDL with appropriate endorsements, to include X or N and no airbrake restrictions.
3. Requires one year driving experience immediately preceding appointment free of incidents which could result in license suspension or revocation.
4. Requires the ability to perform arduous labor.
5. Requires the ability to lift up to 50 pounds.
6. Requires the ability to work in confined spaces, climb steep terrain, and wade in water.

7. Requires the ability to deal with poisonous plants, animals, insects, rodents, and snakes.
8. Requires the ability to perform outdoor work in a variety of conditions including, but not limited to, hot, cold, wet, windy, muddy, active construction sites, and roadways open to traffic.
9. Requires the ability to understand and carry out oral and written instructions.
10. Requires the ability to maintain productive working relationships.
11. Operations employees are subject to call at any hour of the day or night on any day of the year.
12. Occasionally, the department is required to respond to emergencies outside normal work hours. As a result, negotiated rate employees are required to work reasonable amounts of overtime when necessary.
13. Any bargaining unit employee who may be required to engage in a call out shall respond to the call as quickly as practicable but in no situation can the response time exceed forty-five minutes.
