Unofficial college transcripts must be included with application. Official college transcripts must be submitted upon date of employment. Applicants possessing an Engineer Intern License must also include a copy with application. Applicants not submitting these documents by the posting deadline will not be considered for employment.

To be considered for a permanent position within IDOT, you must either be a US citizen or a non-citizen with permanent work authorization.

Only education/coursework and experience listed within the application will be considered for determining eligibility for this position.

Please be advised that if a high volume of applications is received, the applications may be screened to establish a smaller pool of applicants for interview. The screening will be based on the information contained in the application.

Applicants will be notified in writing to schedule interviews.

In an attempt to fill the posted positions, IDOT will contact applicants during the posting period to schedule interviews. All postings will result in three interview pools, with application cut off dates of: September 16, 2020, October 16, 2020 and November 16, 2020. Those applicants that have been deemed qualified and have submitted a completed application with all required attachments will be invited to interview accordingly based on the date their application documents are received.

Position Purpose

This position is accountable for assisting in the layout, inspection, and documentation required on various highway improvement construction projects. This is a training position.

Dimensions

Subordinate Personnel:	Direct - None Indirect - 1-2 on an as-needed basis

Nature and Scope

This position reports to the Resident Engineer. This position may be assigned to a resident technician on a project-by-project basis. When this occurs, the incumbent would report to the resident technician. There are no direct subordinates reporting to this position, but h/she may supervise one to two technicians on direct assignments.

This position assists in providing the contractor with the necessary layout, direction, and inspection required on highway improvement and/or construction projects. His/Her position operates within an environment which ensures the contractor provides quality improvements in accordance with plans, specifications, and special provisions in a timely manner.

Typical problems faced by the incumbent are in the interpretation of the plans and specifications while inspecting and directing the contractor's personnel with compliance of specifications. The greatest challenge is to maintain the application of civil engineering principles to field conditions.

The functions performed by the incumbent include acting as a member on the survey party; inspecting construction operations such as earthwork, drainage, asphalt or concrete pavements, concrete, steel, and other miscellaneous items involved in road and bridge construction; providing necessary reports and documentation for pay items; reducing survey notes; plotting cross-sections; computing quantities; checking computations of others; and assisting the resident engineer on small and uncomplicated construction contracts.

The incumbent is governed by the plans and specifications of the project. H/She refers major problems or necessary plan changes to the Resident Engineer. H/She does, however, accept or reject materials incorporated in the project on the basis of visual or field tests, and assures that all materials have been properly inspected prior to being incorporated into the project.

The incumbent has contacts with resident engineers, project engineers, and personnel from the Bureau of Project Implementation, as well as with contractors and the general public.

The effectiveness of this position will be measured by the timeliness and accuracy of layout, inspection, and reports provided by the incumbent.

Principal Accountabilities

1. Provides accurate measurement, computation, and documentation of contract items to ensure proper payment and completion of pay items in accordance with the contract plans and standard specifications.
2. Keeps Resident Engineer informed of any construction problems encountered or changes made to all for proper engineering judgment to be applied and working plans updated.
3. Inspects pay items and materials to ensure compliance with standard specifications and production of a quality improvement project.
4. Provides the contractor with accurate and timely layouts to allow for project completeness in accordance with the contract plans and the time frame outlined.
5. Performs duties in compliance with departmental safety rules. Performs all duties in a manner conducive to the fair and equitable treatment of all employees.
6. Performs other duties as assigned.




