Under direct supervision of the Operations Supervisor, and the day-to-day guidance of Highway Maintenance Lead/Lead Worker, performs a variety of tasks related to the maintenance, repair and upkeep of roads, bridges and other related structures and features. Operates CDL licensed vehicles.

1. In the performance of duties, operates CDL Class A licensed vehicles including maintenance trucks, pavement marking equipment, tractors, mowing machines, snowplows, salt spreaders, as well as compressors, jack hammers, generators, and other equipment.
 - Washes, greases, and conducts minor repairs and preventative maintenance activities of these vehicles and equipment.

2. Performs labor relating to maintenance of roadways.
 - Repairs, replaces, and patches concrete, bituminous, and other roadway surfaces
 - Loads/unloads trucks
