A divider island to separate the main river channel from the bypass channel is to be constructed of roller compacted concrete and embankment material protected by riprap. The work will also include the fabrication and installation of dam safety signs and buoys and all appurtenant work required to complete the project located at the Yorkville Dam on the Fox River in Yorkville, Illinois approximately 970 feet upstream of the Route 47 Bridge. Major items of work include 8,652 cu yds earth excavation; 1,968 cu yds rock excavation; 3,848 cu yds removal and disposal of unsuitable materials; 4,305 tons stone riprap, Class A5; 10,362 tons stone riprap, Class A5 special; 18,902 sq ft PCC sidewalk, 5-inch; 283 cu yds concrete removal; 159 cu yds concrete structures; mobilization; 2,341 cu grouted boulders; 1,016 tons feature boulders; 1 temporary cofferdam system; and 4,081 cu yds roller compacted concrete.
