### **Submittal for Testing and Approval**

#### **A. Scope**

The following guidelines are provided to clarify the submittal requirements and expedite the testing process for approving polymer concrete according to the Department's Special Provision for Polymer Concrete (Supplemental Specifications and Recurring Special Provisions).

#### **B. Procedure**

When submitting polymer concrete to the Department, the following shall be included:

- The specific product brand name,
- Safety Data Sheet,
- Technical Data Sheet,
- An infrared spectrophotometer trace of current production of each component of the binder material (the IR scan should be labeled with the date the scan was performed, the product name, and the manufacturer's name),
- A signed letter stating the subject material will not be changed without written notification to the Department,
- Contact person's name, title, address, email address, and phone number, and
- Acknowledgement by Company (see next page). [If your company does not already have a product included on an IDOT QPL, please submit a signed copy of the company acknowledgement form with your product submittal.](#)

The manufacturer shall submit a sufficient amount of product (typically 1.5 ft<sup>3</sup>) to be tested according to the Department's specifications. If the Department requests, a technical representative of the manufacturer shall provide appropriate mixing equipment and be present to mix the material.

Any sample provided without the required information listed will not be tested. Any changes in the formulation outside the manufacturer's original parameters will necessitate a new sample submittal.

The manufacturer will be notified when the sample testing is complete. For questions regarding the testing and approval process, contact Melinda Winkelman at 217-782-0117.

#### **C. Recertification**

Annual recertification of all polymer concrete is required. During the last quarter of the calendar year, a recertification letter will be sent to the manufacturer. The recertification paperwork is due January the following year. For example, the recertification letter is mailed November 2018 and due by mid- January 2019.
