**Scope and Procedure for Qualified Producer List**

**A. Scope**

In Pay for Performance contracts, a contractor may dispute test samples. Dispute resolution testing will be permitted when the Contractor submits their split sample test results prior to receiving Department split sample test results. Dispute resolution testing shall be according to Method 1 (pay parameter dispute) or Method 2 (individual parameter dispute) as outlined in the [Appendix E.5 in the IDOT Manual of Test Procedures, "Pay for Performance Dispute Resolution"](#).

**B. Procedure**

To qualify to dispute using Method 2 (individual parameter dispute  $G_{mm}$ ,  $G_{mb}$ , and asphalt content), a Contractor's laboratory must participate in the AASHTO resource's (formerly AMRL) Proficiency Sample Program (PSP) and receive passing ratings in all three parameters ( $G_{mm}$ ,  $G_{mb}$ , and asphalt content). PSP samples are distributed annually to federal, state, independent, commercial, and research testing laboratories. AASHTO re:source scores proficiency test samples by fitting a standard normal distribution to the data from all laboratories (with outliers eliminated).
