Instructions for AER 2048

1. Complete this application by providing pertinent information from your Federal Aircraft Certificate. **Print or Type** all information. Illegible or incomplete applications may be returned.
2. Make remittance payable to the **State Treasurer of Illinois**. The fee is **\$20.00** when paid within the first half of the current biennial registration cycle (even year). Applicants who register within the second half of the current biennial cycle must pay **\$10.00** (odd year). You may contact this Division if you are unsure of the current cycle. Each registration cycle begins January 1st of all even years and expires December 31 of the following odd year.

3. Submit check, draft, or currency exchange money order with application to the following address. **CASH WILL NOT BE ACCEPTED.**

Notes

* Operation of an aircraft, without proper registration of a Federal Aircraft Certificate with this department is a Class A misdemeanor punishable by a fine not to exceed \$1,000 and/or up to one year in jail. See 620 IL Compiled Statutes.

* **Exemptions:** Dealer, Interstate Commerce and Government Aircraft Owners and Air Taxi must file with proof of exemption.

* An Illinois aircraft owner who bases out-of-state, but air navigates within Illinois must register with this Division.

* Registration is not transferable from one aircraft to another. Use this form for registering your aircraft. When you sell your aircraft you must notify this department at the above address by providing the name and address of the new owner.

* The Purchase Information collected on this form is for use by the Illinois Department of Revenue.

* **New registration applications must include one of the following:**

1. A receipt from the Illinois Department of Revenue showing payment of sales or use tax owed has been satisfied.
2. The applicable Tax Return and a check made payable to the Illinois Department of Revenue in the amount of the tax due.
3. A copy of the Bill of Sale, purchase agreement and/or other documentation indicating the net amount of the transaction. Copies will be forwarded to the Illinois Department of Revenue and your certificate held until a release is received by the Department.
