We approve the amendment to the FY2021-2024 Statewide Transportation Improvement Program (STIP) as submitted with your letter dated May 11, 2022, in Districts 2, 7 & 8 as outlined in your letter:

- 1) Whiteside County – Dixon Avenue – IL40 to I & M Feeder Canal - Reconstruction
- 2) Macon County – CH38 - Friends Creek 4.9 miles NE of Argenta - Bridge Replacement
- 3) Marion County – Whittaker Street - South College Avenue to East of Pearl Street in Salem - Reconstruction

Based on the Federal Highway Administration, Illinois Division's ongoing Federal oversight of the planning activities in Illinois, we find that the transportation planning process substantially meets the planning requirements described in 23 CFR 450.
