Dear Ms. Sisk:

We approve the amendment to the FY2021-2024 Statewide Transportation Improvement Program (STIP) as submitted with your letter dated July 7, 2022, in Districts 8 & 9 as outlined in your letter:

- 1) District 8 – Bond County – US40 - .3 miles West of IL127 to Fayette County Line – Resurfacing & ADA Improvements
- 2) District 8 – Bond County – US40 – B & N RR at Smithboro – Bridge Deck and Overlay
- 3) District 9 – Jackson County – IL147 - .9 miles East of IL3 – Bridge Overlay

Based on the Federal Highway Administration, Illinois Division's ongoing Federal oversight of the planning activities in Illinois, we find that the transportation planning process substantially meets the planning requirements described in 23 CFR 450. We can now consider project authorization requests related to this STIP Amendment.
