- 2. Effective January 1, 2017, a one-time pilot registration fee of \$20.00 is required. A Certificate of Registration, with no expiration date, will be mailed to the registrant as soon as possible.
- 3. Make remittance payable to the State Treasurer of Illinois. CASH WILL NOT BE ACCEPTED.
- 4. Submit check, draft, or currency exchange money order with application to the following address:
