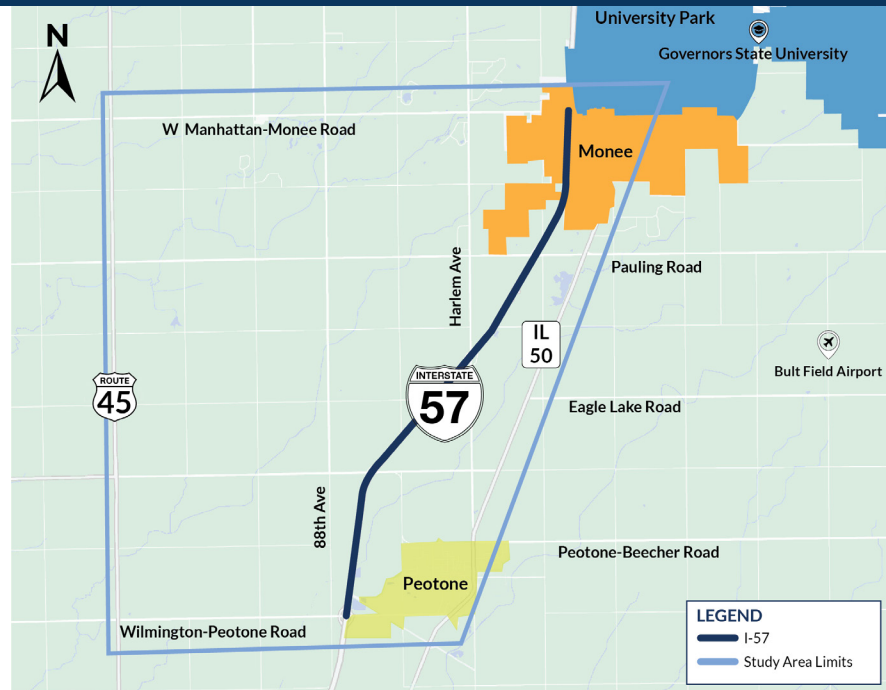


I-57 Access Study

South of Wilmington-Peotone Rd. to North of Manhattan-Monee Rd.

The I-57 Access Study is a Phase I study, consisting of preliminary engineering and environmental studies to improve access to I-57 in Will County. The study area is bounded by Wilmington-Peotone Rd (south), Manhattan-Monee Rd (north), US Route 45 (west), and 1-mile east of IL 50 (east). The Villages of Peotone, Monee, and University Park are included in the study area.

The study will analyze existing conditions, establish a purpose and need, develop a reasonable range of alternatives, and recommend a preferred alternative. The I-57 Access Study aims to propose access improvements to I-57 to meet future traffic needs and improve local and regional connectivity to I-57.

IDOT's Project Process

The I-57 Access Study is currently in Phase I, which includes data collection, identification of the study's Purpose & Need, and public review and consideration of potential improvement alternatives prior to selection of a preferred alternative. Phase I is expected to conclude in 2027.

Upon conclusion of Phase I, the study proceeds to Phase II which consists of contract plan preparation and land acquisition. Phase II typically takes 24-36 months and is followed by Phase III, construction, which takes 24-36 months.

This improvement is included in the Department's FY 2025-2030 Proposed Highway Improvement Program.

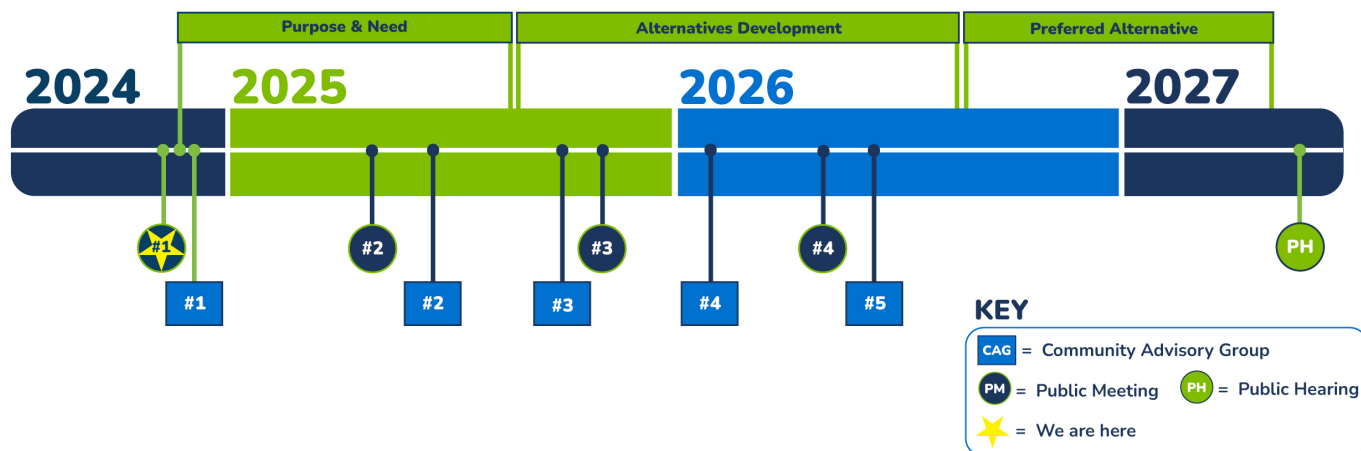
