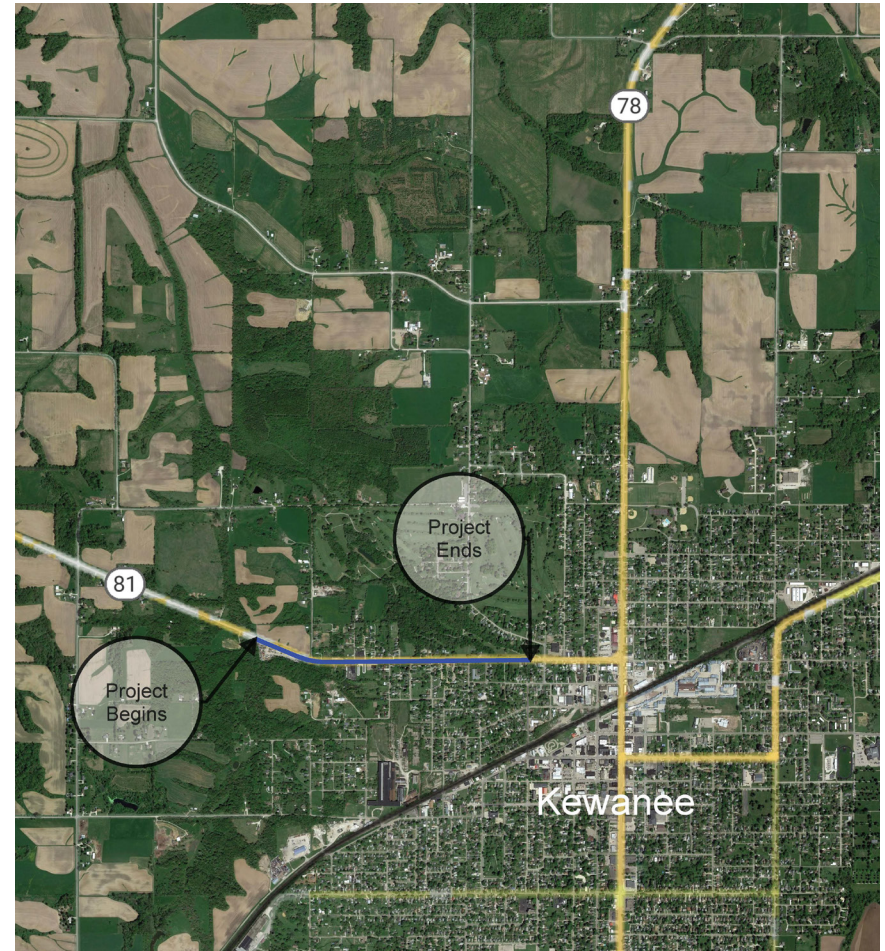
# WHAT'S NEXT?

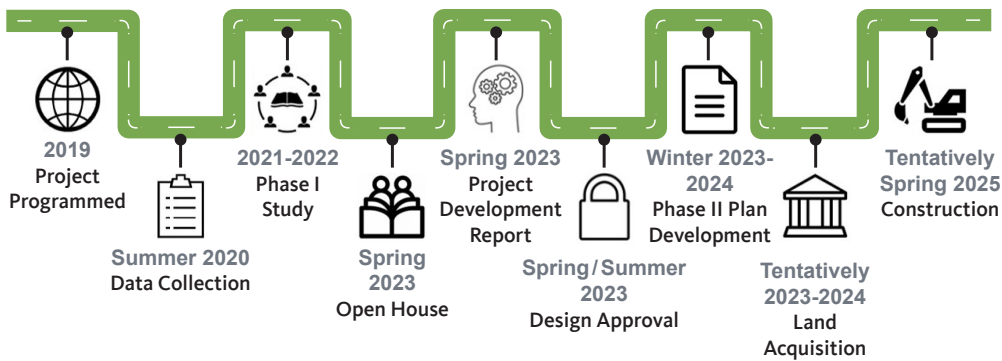
Construction is tentatively programmed for Spring of 2025.

## PROPOSED LIMITS OF IMPROVEMENT

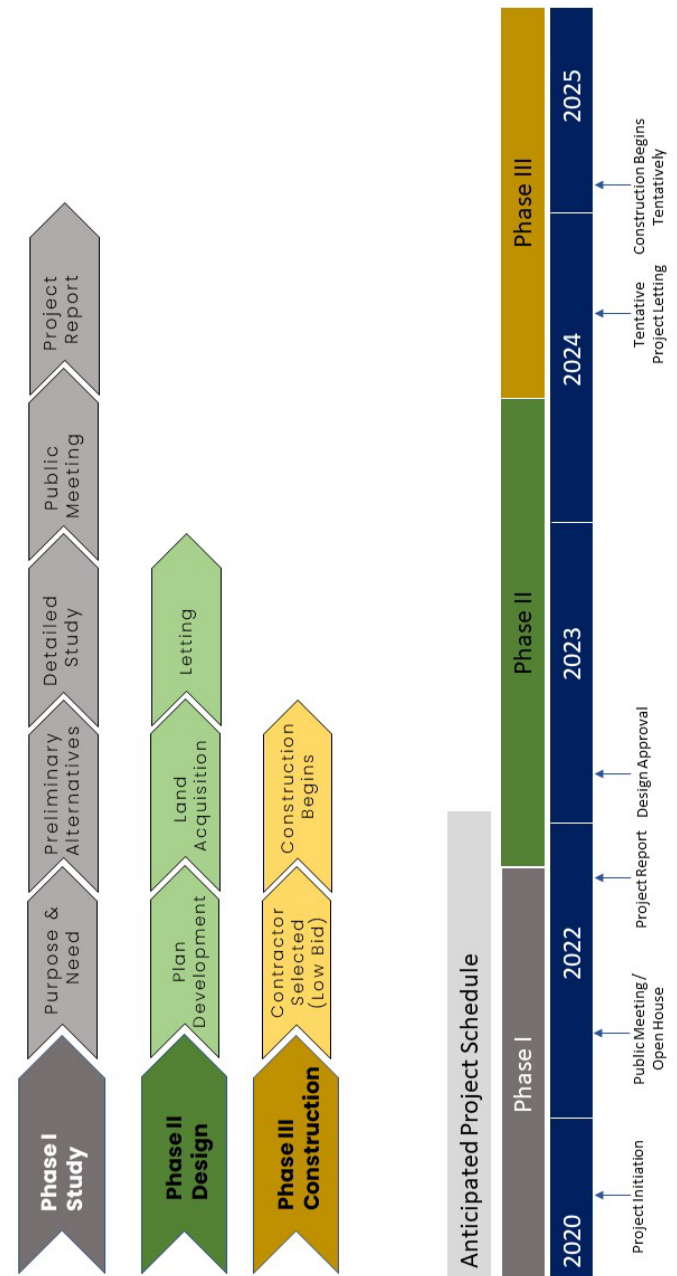


# Scope of Work

IL 81 (W. 6th Street) is an urban minor arterial providing the motoring public access to Kewanee IL from the west. This arterial is mostly surrounded by residential but does provide access to local business and parks. Due to the deterioration of the existing pavement conditions, IDOT has recognized that the pavement is in need of complete replacement as well as improving drainage to improve safety and access. IL 81 will be reconstructed from 0.2 miles W. of Union Street to 0.3 Miles W. of IL 78 with one 13-foot lane in each direction, curb and gutter, storm sewer, upgrades to culverts, a sidewalk replacement on the south right-of-way and a new 10-ft multi-use path on the north side providing pedestrian/bicycle access from Union Street to N. Lexington Ave.
