Project Overview

The Illinois Department of Transportation (IDOT) is evaluating potential improvements to IL 84/IL 92 in the City of Silvis. The project is located within Rock Island County and extends from west of 19th Street to the IL 5 interchange in Silvis.

IL 84/IL 92 (1st Avenue) in Silvis is a principal arterial in IDOT's roadway network and an important east-west corridor through the city of Silvis. The concrete pavement was originally constructed in 1938. The facility carries over 9,800 vehicles and heavy trucks per day, serving the eastern parts of the Quad Cities. Due to the poor condition of the existing roadway, IDOT has initiated this project to evaluate rehabilitation and reconstruction of the facility.

Study Process and Findings

The study includes identifying transportation needs, developing and evaluating alternatives (*or potential improvements*) and identifying a Preferred Alternative (*or a final recommendation*).

The overall project scope includes:

- ➔ Pavement replacement/rehabilitation
- ➔ Traffic management alternatives
- ➔ Intersection improvements
- ➔ Parking accommodations
- ➔ Bicycle and pedestrian facilities
- ➔ Drainage system replacements

Project Process and Schedule

This study process follows state and federal requirements for evaluating transportation improvements. During Phase I, the project team conducts preliminary engineering and environmental studies as well as stakeholder coordination. During Phase II, detailed design plans are prepared and any land acquisition for the project will occur. Phase III includes constructing the project.

IDOT Project Development Process



Proposed improvements under consideration include pavement reconstruction; new sidewalks and/or shared-use paths on both sides of the roadway; on-street parking on the west end and in the business district; center two-way left turn lane on the east end; separated bicycle lane through the business district; and new curb and gutter and storm sewers.

Additional right-of-way will be required from several properties for the proposed improvements. The project includes potential impacts to Section 4(f) properties: Hero Street Memorial Park at 2nd Street, Railway Park and Gazebo at 11th Street, and 17th Street Park.
