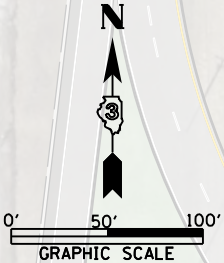


RECOMMENDED ALTERNATIVE
