## Summary of Public Hearing IL 47: from IL 71 to Caton Farm Road

A public hearing was held on August 19, 2015 from 4:00 p.m. to 7:00 p.m. at the Yorkville Public Library. The purpose of the hearing was to present the proposed plan for reconstructing IL 47, present project impacts, provide land acquisition and relocation assistance information, and answer project questions and receive public comments. The hearing was announced by advertisement in local newspapers, through a press release to local media, through the IDOT website and by letters to local officials, public service providers, legislators, and property owners adjacent to the proposed improvement.

The hearing's display materials consisted of exhibits explaining the project purpose & need, anticipated impacts, aerial photography showing the proposed reconstruction and right of way limits, existing and proposed roadway typical sections, a location map, a map depicting five years of crash records, and traffic projections. After the conclusion of the meeting, copies of the exhibits, brochures and comment sheets were available for review at the Yorkville City Hall, at the District 3 office in Ottawa, and on the IDOT website at <a href="http://www.idot.illinois.gov/projects/il-47-project">http://www.idot.illinois.gov/projects/il-47-project</a> under the Resources tab.

Forty-five individuals signed in at the hearing including city, township, and county officials and a newspaper representative. IDOT staff and representatives from the consultant engineering firm were present to provide information and answer questions.

The comment period ended on September 2, 2015. A total of six (6) comment forms were submitted. Some forms had multiple comments. The table below provides a synopsis of the comments and IDOT's responses.
