# Community Advisory Group Meeting # 1 August 25, 2011 - Yorkville Public Library

The first Community Advisory Group meeting for the IL Route 47 study was held on Thursday, August 25, 2011 at the Yorkville Public Library. The meeting featured a presentation from the Project Study Group, large scale maps of the study area, exhibit boards for review, and an interactive workshop which allowed meeting attendees to identify study area issues and concerns. The Project Study Group's presentation included a summary of the following: the Phase I process; the project's study limits and existing characteristics; results from the first public meeting; project schedule and funding; other area projects; and, an overview of Context Sensitive Solutions (CSS) principles and process. The meeting was attended by **9 stakeholders.**

#### Safety

- School speed zone
- School safety

#### **Intersection safety**

- Additional traffic signals
- o 4-Lane and turning lane?
- o Stop light at Legion?
- o Address intersections first turn lanes
- o Access in/out of Windett Ridge subdivision
- o Turn lanes to help flow and prevent rear end collisions
- o Stop light at Ament?
- Walker Road intersection visibility
- Access in-out Bonnie Lane

#### Improve traffic flow and alleviate congestion

- o Move traffic regionally, not just locally
- o Ability to safely pass slower vehicles (ie trucks)
- Limit curb cuts that slow traffic flow
- o Improve access to I-80 and I-80 to I-88 connection
- Concerned ribbon development of commercial/retail will increase stop lights and slow traffic flow
- o Traffic congestion
