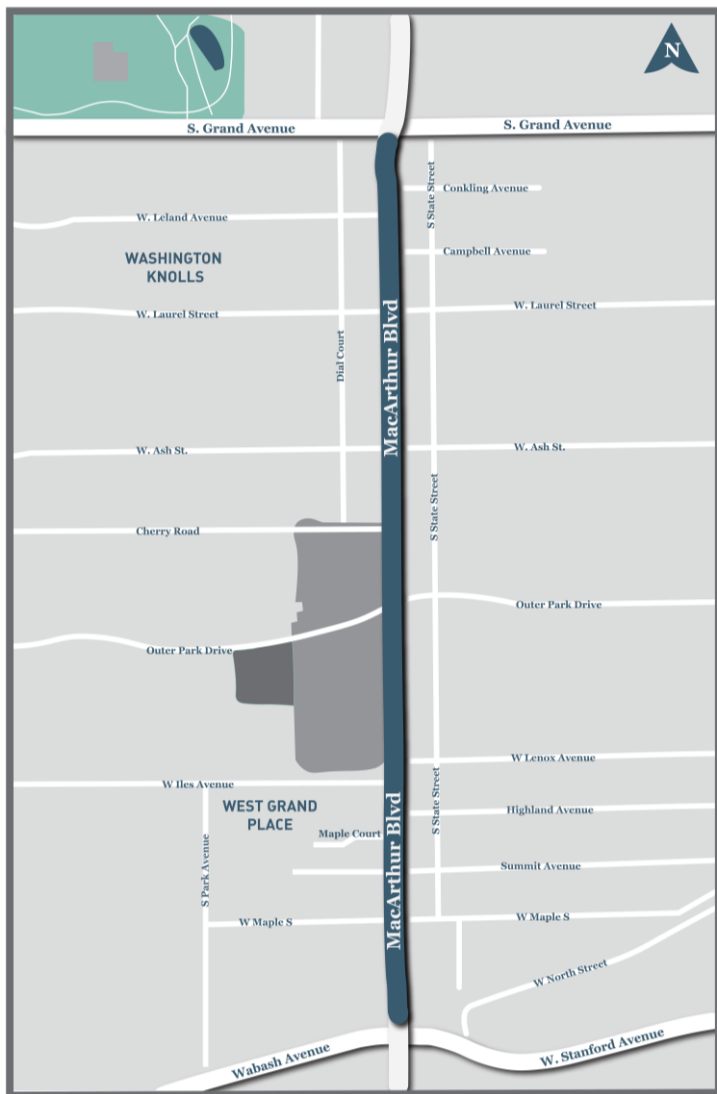

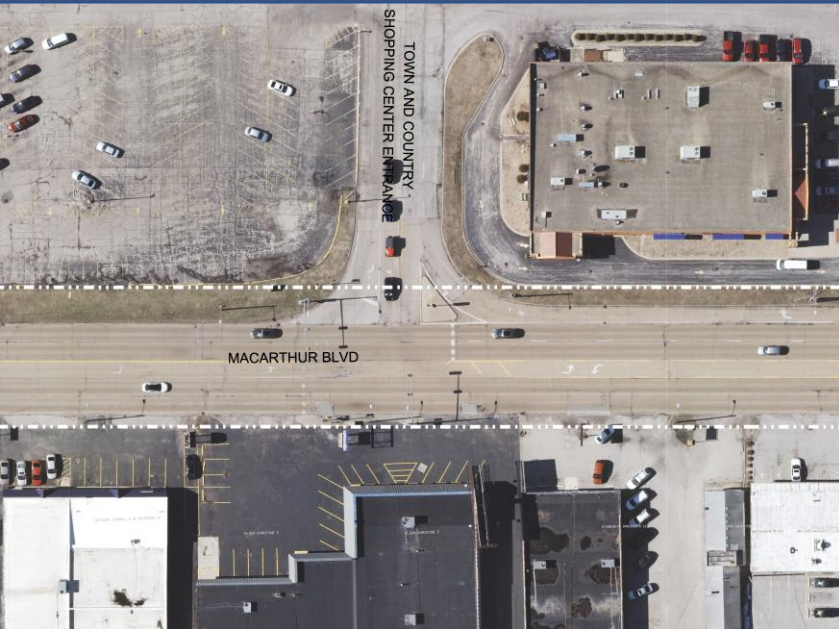

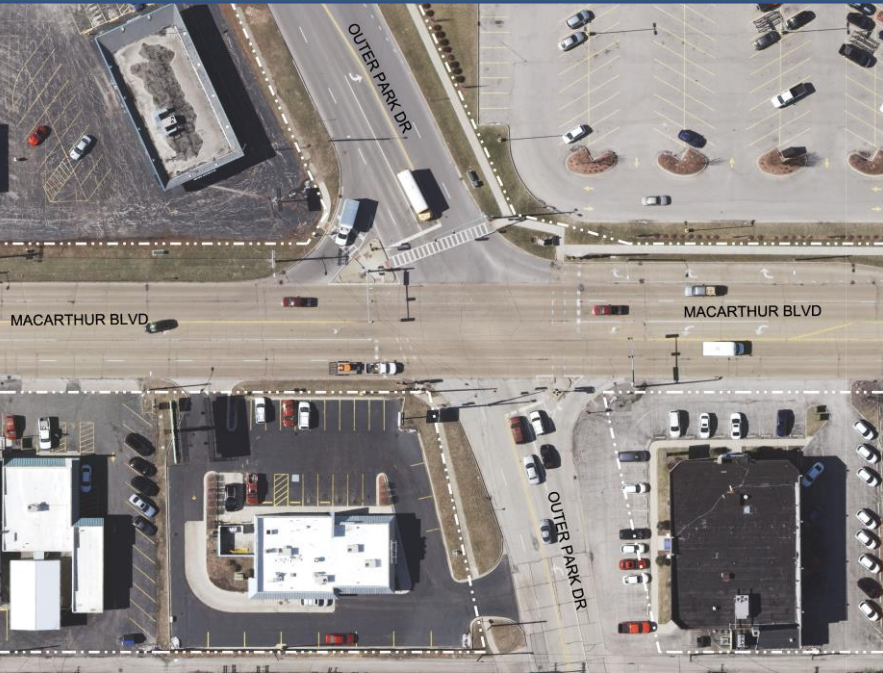

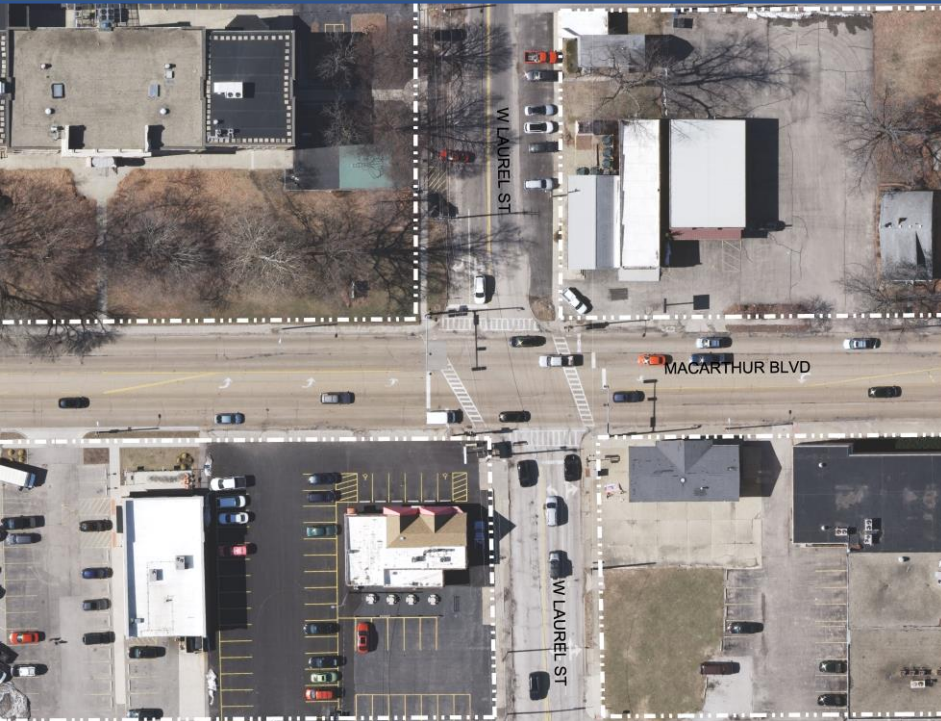

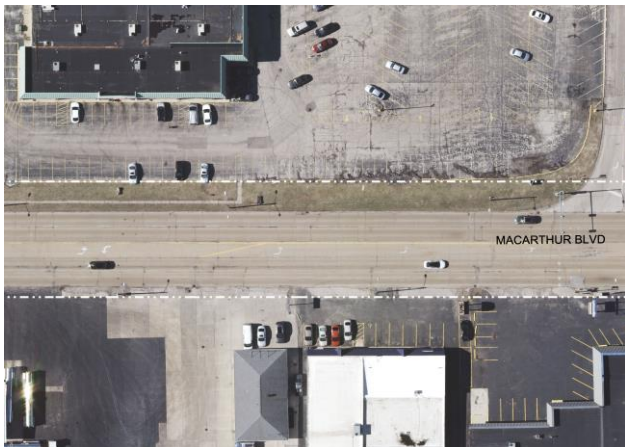

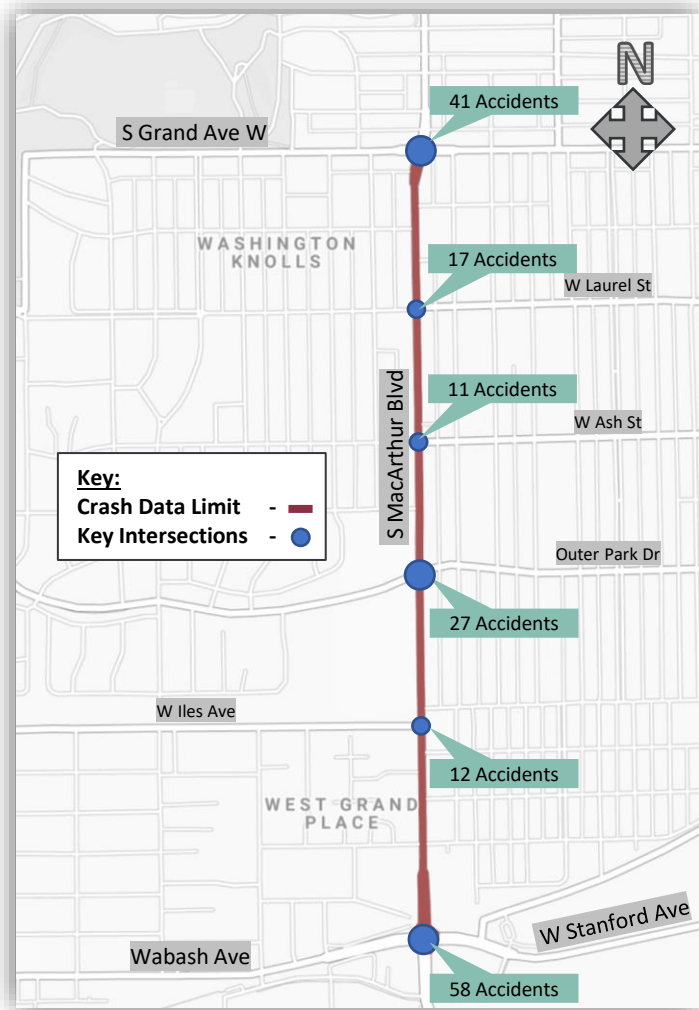

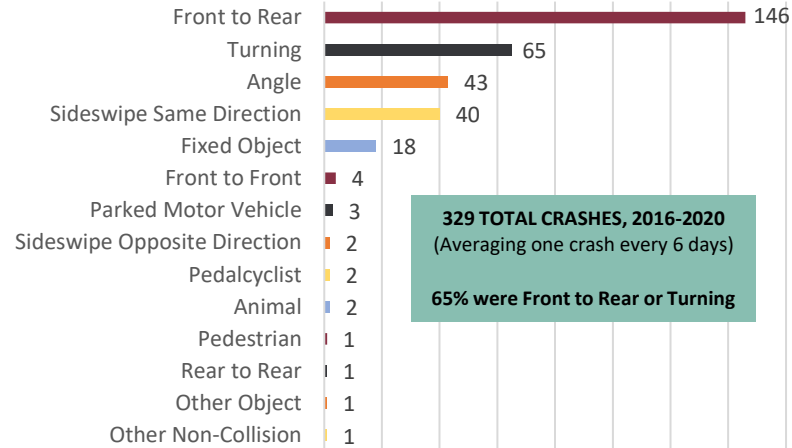


Existing Conditions - Crash Analysis

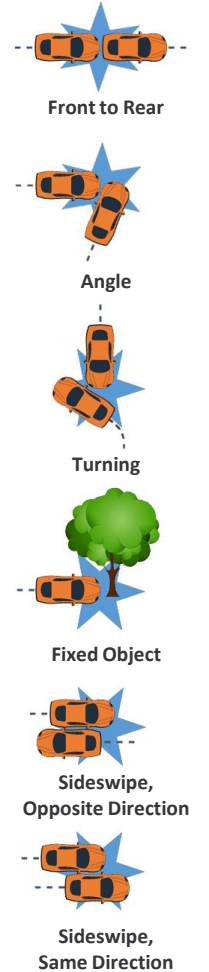

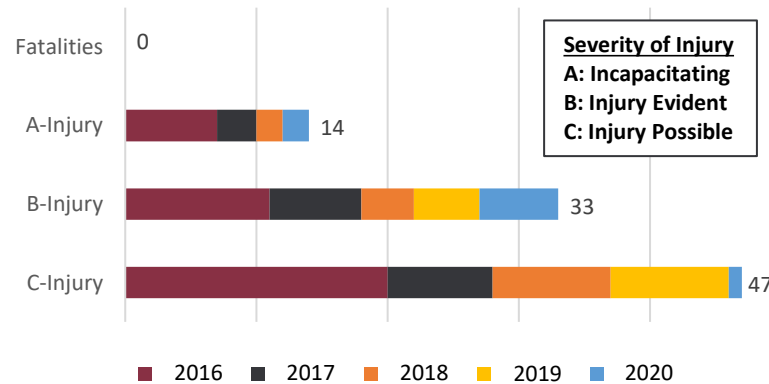
Wabash/Stanford to South Grand, 2016-2020
