


WHAT IS THE PURPOSE OF THE IDOT STUDY



This study is taking a detailed look at options for:

- Resurfacing of the roadway
- Reconstruction of the sidewalk ramps and curb ramps to be ADA compliant
- Addition of a secured shared-use path along the east side of Water Street by eliminating the fourth lane
- Traffic signal & intersection modifications
- Roadway lighting updates
- Drainage Improvements



PURPOSE & NEED FOR THE PROJECT



The purpose and need for improvements along Water & Main Streets within the project limits are due to:


- Condition of the roadway, sidewalks, and drainage system
- Lack of pedestrian & biking mobility
- Enhance safety throughout the study area

- The limits of the IDOT Business Route 51 Study and the City's Bike/Walkway Study overlap.
- The goals of both studies complement each other:
 - Enhancing the safety of the route and providing better connection to key destination along the project corridor.
 - Repurposing of right-of-way along Business Route 51 to include a shared-use path.
- The focus of IDOT's study, as the state agency, is how best to improve the state route, which is Business Route 51, locally known as Main and Water Streets, and the associated intersection and sidewalk ramps in addition to adding a secured shared-use path along the project route.
- The focus of City's study, as the local agency, is how to use vacated properties along the route and provide a direct and positive impact on the adjoining neighborhoods by improving walkability by repairing the sidewalks and beautifying with trees and vegetation.

IDOT THREE-PHASE PROJECT PROCESS



IDOT has a three-phase project development process, as shown on the timeline graphic below. The Business Route 51 Study includes funds to conduct Phase I, which provides the support for determining a preferred option. During this phase the proposed geometry, environmental concerns, and proposed right-of-way are identified.

SUMMARY OF PUBLIC MEETING #1



- March 30, 2023
- Decatur Civic Center
- 121 people attended
- 43 people made comments
 - ✓ 75% of those that made comments were in favor of the overall proposed improvements
 - ✓ 11% of those that made comments were not in favor of the overall proposed improvements
 - ✓ 14% of those that made comments it was unclear on their position.

COMMENT SUMMARY OF PUBLIC MEETING #1



COMMENT	HOW BEING ADDRESSED?
Cars driving way too fast on Water Street	<ul style="list-style-type: none"> Speed limit signs will be added to the entire length of the project. IDOT to possibly add these signs in the near future. Reduction in both the number and width of lanes will help reduce speeds of the NB vehicles.
Add stop light at McKinley & Water Streets	<ul style="list-style-type: none"> IDOT is currently conducting an engineering study called a “traffic signal warrant study” to determine if a traffic signal is warranted at this intersection.
Marietta and Water Street is a dangerous intersection	<ul style="list-style-type: none"> There has been communication between the City of Decatur and IDOT regarding options at this intersection due to the poor sight distance.
Signage is important	<ul style="list-style-type: none"> Signing from the beginning to the end of the shared use path will be provided. Speed limit signs will be added on Main Street & Water Street. IDOT to possibly add these signs in the near future. After construction, the use of changeable message boards will be placed along the routes to inform the traveling public of the changes in lane usage.
Backup of traffic due to the stalling of trains is a problem.	<ul style="list-style-type: none"> The congestion is due to the railroad. The project will not affect the number of through lanes in this area as it is currently three lanes. The project does not include addressing the congestion associated with the railroads due to time and cost.
Resurfacing of the roadway is a major need	<ul style="list-style-type: none"> Resurfacing of Water and Main Street will take place along the entire length of the project corridor.
Street parking is an issue along Business Route 51 because of the low visibility to motorists.	<ul style="list-style-type: none"> Current parking on Water Street from Division St to Johnson Ave will be eliminated. On-street parking on Main Street is still being evaluated.
Pedestrians are walking in the street because of the lack of sidewalks in the area.	<ul style="list-style-type: none"> The shared-use path will provide an area for pedestrians to walk. Along Water Street and Main Street, the sidewalk ramps will be upgraded as part of this project. Currently, IDOT is working with the city of Decatur on upgrades to the sidewalks on Water Street and Main Street.
Comments addressed to the city Decatur – zoning is important, beautify this area, add lighting, native plants.	<ul style="list-style-type: none"> The focus of City’s study, as the local agency, is how to use vacated properties along the route and provide a direct and positive impact on the adjoining neighborhoods by improving walkability by repairing the sidewalks and beautifying with trees and vegetation. IDOT is currently working with the City on lighting upgrades.
Add a crosswalk at Damon & Water	The existing pedestrian crosswalk, which does not meet current standards, is still being evaluated.
Add a crosswalk at Pershing & main	There are currently no plans to add crossings where there currently are none.
Add sidewalk between Pershing & Van Buren	There are currently no plans to add sidewalks where there currently are none
Add sidewalk between Pershing & Damon	There are currently no plans to add sidewalks where there currently are none



SUMMARY OF PUBLIC MEETING #2



- November 2, 2023
- Main Street of the Living God
- 106 people attended
- A majority of the public meeting attendees either through making comments on the forms or in conversation:
 - ✓ Are in favor of the overall project.
 - ✓ Regarding the intersection of E. Marietta and Water Street, stated this intersection is unsafe and wish to see a traffic signal at this intersection.
 - ✓ Wish to have the on-street parking remain on Main Street.
 - ✓ Wish to see a stoplight at McKinley and Water Street.








DESCRIPTION OF PROPOSED IMPROVEMENTS

INTERSECTION BUMPOUTS

Bumpouts effectively make the pedestrian crossing shorter by extending the curb into the street at those crossings



Bumpouts are proposed for:

- Water Street @ E Grand Ave
- E Marietta St @ Water Street
- W Johnson Ave @ Main Street
- W Division St @ Main Street
- W Leafland Ave @ Main Street
- W Green St @ Main Street

SIGNALIZED INTERSECTIONS

The existing traffic signals at the following intersections are proposed to be replaced with new traffic signals:

- Pershing Road @ Water Street and @ Main Street
- McKinley Avenue @ Main Street
- Garfield Avenue @ Water Street and @ Main Street
- Grand Avenue @ Water Street and @ Main Street
- Marietta Street @ Main Street
- Green Street @ Main Street



Addition of a traffic signal at McKinley Avenue & Water Street

SHARED-USE PATH

ONLY ON WATER STREET

- Proposed to replace the eastern most lane along Water Street
- Reduces the lanes on Water Street from four lanes to three lanes
- 10-foot shared-use path
- 7-foot buffer between the shared-use path and the edge of the traffic lane that consists of a barrier curb and landscaped area.
- City of Decatur will be maintaining the shared-use path



- The project team will continue to work with the City of Decatur to ensure the preferred alternative addresses the identified transportation issues and public's concerns & complements the City's Bike/Walkway Study Plan.
