RE: 2024 Highway Safety Improvement Program Call for Applications

Dear Mr. Riddle:

On behalf of Kane County, I am pleased to submit to you an application for HSIP funding to make systemic safety improvements at rural curves throughout the County. The goal of these improvements is to reduce the number of run off road and lane departure crashes occurring at rural curve locations identified in a previous study by the County.

Our Staff reviewed County crash data for high crash locations and hot spots within our roadway network and recommends these segments be prioritized for safety improvements. The 2018 to 2022 crash data revealed a high concentration of lane departure crashes.

Kane County intends to use the HSIP funding to provide a wider white edge line stripe, chevrons, additional warning signs, and/or advisory speed limit signs. These improvements will be performed as needed at locations identified in a previous study by the County. Several locations will receive warning flashing beacons on signs or a chip seal pavement treatment to increase curve awareness and lower wet-weather crash rates, the costs of which have been included within the requested HSIP funds. As these locations are already benefiting from other safety improvements with a combined CMF of 0.6 (the maximum allowed), these additional measures would not offer further benefit in the B/C analysis and were therefore conservatively grouped as non-safety improvements.

According to the cost-benefit tool provided by IDOT, the benefits significantly outweigh the costs of this project. I urge the State to award HSIP funding to improve the safety of this segment.

LOCATION INFORMATION / EXISTING CONDITIONS

The proposed systemic project focuses on rural sections of road where there are curves present. The conditions along individual highways may be different from what is described below, but the purpose of providing this document is to give a summary of the most common road characteristics present within this study to allow a reviewer to better understand the project.

Roads were generally two-lane bi-directional rural highways. Oftentimes speed limits were >40mph with many roads being posted at 55mph. Generally, the project locations are along stretches of highway that do not pass through residential or business areas. Shoulders, if present, are generally small and cannot be used as an emergency lane.

CRASH ANALYSIS

This section provides a summary of the crash data from 2018-2022 inclusive of all proposed improvement locations.

- 858 Total Crashes (27 miles total)
 - 403 (47%) Rear End: 1 A-injury, 49 B-injury, 51 C-injury
 - 167 (20%) Turning Left: 1 Fatal, 42 B-injury, 22 C-injury
 - 67 (8%) Fixed Object: 1 Fatal, 3 A-injury, 8 B-injury, 5 C-injury
 - 51 (6%) Turning Right: 6 B-injury, 2 C-injury
 - 44 (5%) Animal: 1 A-injury, 2 B-injury, 2 C-injury
 - 39 (4%) Sideswipe Same Direction: 1 A-injury, 4 B-injury
 - 35 (4%) Angle: 2 A-injury, 7 B-injury, 13 C-injury
 - 14 (2%) Sideswipe Opposite Direction: 3 A-injury, 2 B-injury, 2 C-injury
 - 10 (1%) Other Object: 1 A-injury, 1 B-injury, 1 C-injury
 - 8 (1%) Other Non-Collision: 1 B-injury
 - 8 (1%) Overtaken: 1 A-injury, 2 B-injury, 1 C-injury
 - 8 (1%) Head On: 1 Fatal, 2 A-injury, 2 B-injury, 1 C-injury
 - 3 (0%) Pedalcyclist: 1 Fatal, 2 B-injury
 - 1 (0%) Pedestrian: 1 B-injury

There was a total of 858 crashes within the 5 years studied along these segments including 4 Fatal crashes, 32 A-injuries, 129 B-injuries, and 100 C-injury. The most common crash types were rear end, animal, and fixed object. While reviewing crashes along the curves it was found that any location with major intersections gave a bump to the total crash volume of the curve. To help mitigate this unintentional weighting intersection crashes were reviewed to ensure the crash involved the studied routes.


The primary goal of this systemic project is to address lane departure crashes such as fixed object, sideswipe opposite direction, and head on crashes – as well as minor run off road crashes that may not have been reported to the crash database. Roughly 11% of all crashes studied were lane

departure crashes. This represents a significant portion of the crashes and does not include other crash types where a lane departure may have occurred but was not the primary reason for the crash. Two of the four fatal crashes were lane departure crashes. Due to the frequency and severity of lane departure crashes it will greatly benefit the County to perform systemic improvements across all identified 120 rural curve locations to address lane departure crashes at locations with similar geometry and existing conditions. Some curves may not have as high of a crash rate as the higher ranked locations, but they have the potential to be as dangerous as similar curves that do have high crash rates and were included in this project as a preventative measure.

HSIP funds are requested for a systemic improvement safety project to rural curves throughout Kane County. This project targets rural curve locations where improvement types and locations were recommended based on a previous studies finding and include: adding wider outside striping, adding chevrons to the curving section, installing curve warning signs, and/or posting an advisory speed. In addition to the above-mentioned improvements select curves will also receive flashing warning lights on signs and/or chip seal applications. The two additional improvements will improve site conditions wherever they are applied but for ease of B/C calculation it was decided to include the improvements at a CMF of 1.0.

The total project cost is estimated at \$994,530.88, 90% of the total project cost (\$895,077.79) is requested from the State of Illinois' Highway Safety Improvement Program. The project, if awarded funding, is scheduled to begin October 2024 and proceed to letting in January FY2026. The project spans across multiple county highways to address curving locations that are currently deficient based on a 2022 systemic study. In general locations are located along the curved portion of 2-lane highways with an ADT roughly ~5000 daily vehicles. ADT and lane count was not considered as part of the study and may vary significantly based upon location.

A substantial portion of the crashes involved lane or roadway departures. Crashes were spread relatively evenly throughout the various curve locations. From 2018-2022, 4 fatal crashes, 32 A-type injury crashes, 129 B-Type injury crashes, and 100 C-Type injury crashes were observed. The crash distribution consists of 403 rear end, 167 turning left, 67 fixed object, 51 turning right, 44 animal, 39 sideswipe same direction, 35 angle, 14 sideswipe opposite direction, 10 other object, 8 overturned, 8 head on, 8 other non-collision, 3 pedal cyclist, and 1 pedestrian. All crashes were associated with similar improvement tiers and given a weighted benefit/cost ratio.

Multiple BC sheets were prepared to account for the systemic nature of the project and since not all improvements were necessary at every location. To give the project an overall BC each individual group was weighted based on the total cost of improvements and a final weighted BC score was found. The project has a weighted benefit-cost of 10.34 using IDOT's B/C tool.
