Accessibility update: Title II of the ADA Obligations and Facts

The basic requirement of <u>Title II of the ADA</u> is that agencies must ensure that individuals with disabilities are not excluded from programs, services, and activities. Note that sidewalks, curb ramps, and push buttons at pedestrian signals are considered a program or service. People with disabilities must have an equal opportunity to participate in and benefit from state and local governments' programs, services, and activities. Title II of the ADA is part of the Code of Federal Regulations (CFR): 28 CFR Part 35. <u>READ MORE</u>

Inaugural Sewer Cleaning Training a Success



The manual is the national standard for traffic signs, signals and pavement markings to ensure a uniform and predictable environment for people who walk, bike and drive.
