Pedestrian Stop Data Sheet Instructions

According to Public Act 99-0352, "Whenever a law enforcement officer subjects a pedestrian to detention in a public place, he or she shall complete a uniform pedestrian stop card."

What is a detention?

A detention means all frisks, searches, summons, and arrests.

The Pedestrian Stop Data Sheet provides the required data elements that will need to collected and submitted to IDOT. January through June data must be submitted by August 1st of each year and July through December data must be submitted by March 1st of the following year.

Agency Code

This number is unique to your agency and provided by IDOT. (This field is not required to be completed since this is for internal use only. This field is not included in the DB File Format)

Format: 5 digit number (Example: 12354)

Date of Stop

This is the date the pedestrian stop occurred.

Format: MM/DD/YYYY (Example: 01/01/2024)

Time of Stop

This is the time the pedestrian stop occurred. The time of stop should be recorded in military time.

> Format: HH:MM (Example: 15:45)

Officer Name

This field should list name of the officer who conducted the pedestrian stop.

Example: Chris Jones

Officer Badge Number

This should list the badge number of the officer who conducted the pedestrian stop.

Example: 245

Location of Stop

This should list the physical address of where the stop occurred.

Example: 500 Main St.

Beat Location of Stop

Enter the beat location of the stop. This field should indicate where the stop occurred. It is up to the agency to determine the best method to identify location of stop using this field.

Gender

Select the gender of the person.

- ➤ 1: Male
- > 2: Female
- > 3: Gender X (Non-Binary, etc.)
- > 9: Unknown

Race

Select the race of the person. This should be the officer's "subjective determination of the race of the person stopped." The race categories are: American Indian or Alaska Native, Asian, Black or African American, Hispanic or Latino, Native Hawaiian or Other Pacific Islander, White. To be consistent with the previous form, the categories will be listed in the following order:

- > 1: White
- 2: Black or African American
- 3: American Indian or Alaska Native
- ➤ 4: Hispanic or Latino
- > 5: Asian
- ➤ 6: Native Hawaiian or Other Pacific Islander

Public Act 99-0352 provides a description for each race category.

- "White" means a person having origins in any of the original peoples of Europe, the Middle East, or North Africa.
- "Black or African American" means a person having origins in any of the black racial groups of Africa. Terms such as "Haitian" or "Negro" can be used in addition to "Black or African American".
- "American Indian or Alaska Native" means a person having origins in any of the original peoples of North and South America, including Central America, and who maintains tribal affiliation or community attachment.
- "Hispanic or Latino" means a person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin, regardless of race.
- "Asian" means a person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent, including, but not limited to, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.
- "Native Hawaiian or Other Pacific Islander" means a person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.

Reason(s) for Stop

When an officer has reasonable suspicion that a person is committing a crime or about to commit a crime, the officer can stop the person for further investigation. When completing this section, <u>all alleged reasons should be selected</u>, and if there are other reasons not listed, please select "Other" and you must specify the reasons in the field provided.

- ➤ 1: Actions indicative of engaging in drug transaction
- 2: Fits description from radio broadcast / Call for service
- 3: Fits description of an offender as described by victim or witness
- 4: Actions indicative of "casing" victim or location
- 5: Proximity to the reported crime location
- ➢ 6: Gang related enforcement
- > 7: Suspicious Activity
- 8: Other (Specify) ______

Pat Down/Frisk Conducted?

If the officer reasonably suspects that the person stopped is armed and dangerous, the officer may conduct a frisk, a pat down of the person's outer clothing. (Terry v. Ohio (No. 67)).

Choose "Yes" or "No" for this field.

- Yes Officer conducted a pat down/frisk of the person.
- ➤ No Officer did not conduct a pat down/frisk of the person.

Pat down/Frisk Conducted By?

If "Yes" is selected for "Pat down/Frisk Conducted?", then you must specify the means by which the search was conducted.

If "No" is selected for "Pat down/Frisk Conducted?", then this field is Not Applicable.

- Consent the person gave consent to pat down/frisk.
- Reasonable Suspicion

Reason for Pat Down/Frisk (Check all that apply)

When completing this section, <u>all alleged reasons should be selected</u>, and if there are other reasons not listed, please select "Other" and you must specify the reasons in the field provided.

- 1: Verbal threats of violence by suspect
- 2: Knowledge of suspect's prior criminal violent behavior/use of force/use of weapon
- > 3: Actions indicative of engaging in violent behavior
- ➤ 4: Violent crime suspected
- ➤ 5: Suspicious bulge/object
- ➤ 6: Evasive, false or inconsistent response to officer's questions
- > 7: Other reasonable suspicion of weapon (Specify)

If a Pat Down/Frisk was conducted, did it lead to a search beyond the pat down/frisk?

If "Yes" is selected for "Pat down/Frisk Conducted?", then you must specify whether the Pat Down/Frisk lead to a Search Beyond.

If "No" is selected for "Pat down/Frisk Conducted?", then this field is Not Applicable.

- > Yes Officer conducted a pat down/frisk of the person and it lead to a Search Beyond.
- ➤ No Officer conducted a pat down/frisk of the person but it did not lead to a Search Beyond.

Search Beyond Pat Down/Frisk Conducted?

Choose "Yes" or "No" for this field.

- Yes Officer conducted a Search Beyond a pat down/frisk of the person.
- ➤ No Officer did not conduct a Search Beyond a pat down/frisk of the person.

Search Beyond Conducted By?

If "Yes" is selected for "Search Beyond Pat down/Frisk Conducted?", then you must specify the means by which the search was conducted.

If "No" is selected for "Search Beyond Pat down/Frisk Conducted?", then this field is Not Applicable.

- Consent the person gave consent to a Search Beyond a pat down/frisk.
- Probable Cause
- Search Incident to Arrest

Reason for Search Beyond Pat Down/Frisk (Check all that apply)

When completing this section, <u>all alleged reasons should be selected</u>, and if there are other reasons not listed, please select "Other" and you must specify the reasons in the field provided.

- > 1: Drugs or drug paraphernalia found
- 2: Hard object felt during pat down

- > 3: Firearm found during pat down
- ➤ 4: Other weapon found during pat down
- 5: Other probable cause (Specify)

SEARCH BEYOND PAT DOWN/FRISK CONTRABAND INFORMATION

If "Yes" is selected for "Search Beyond Pat Down/Frisk Conducted" then you must specify whether or not contraband was found, the type of contraband found, and the amount (if the contraband found was drugs).

If "No" is selected for "Search Beyond Pat Down/Frisk Conducted?" then these fields are Not Applicable.

If a Search Beyond a Pat Down/Frisk was conducted, was contraband found?
