# Key Focus Area: Partnerships

- Importance of partnerships for resource sharing and interagency collaboration
- Strategies to involve community groups and other external transportation planning partners
- > Examples:
  - Data Sharing
  - Regional Coordination Groups
  - MOUs

# Key Focus Area: Planning Strategies

- Overview of effective planning strategies across urban, suburban, and rural land use contexts
- Strategies to integrate effective community engagement and equity in active transportation planning
- Case studies:
  - Suburban: Chicago Heights Active Transportation Plan
  - Regional: West Central Municipal Conference Regional Bikeways Plan

# Key Focus Area: Funding Sources

- > Overview and resources for applying to federal, state, and local grant programs
- > Examples of Illinois active transportation project funding awards:
  - ITEP: Village of Algonquin awarded \$1.1 million to build a protected bike lane
  - Tri-County Regional Planning Commission's Special Transportation Studies
    Fund: East Peoria awarded \$50,000 to develop a trail network feasibility study
  - Metro East Park and Recreation District (MEPRD) Park and Trail Grant Program and Community Planning Grant Program

# Key Focus Area: Design Guidance

- Importance of uniform but flexible design standards for active transportation projects
- Strategies for navigating and implementing design standards and other resources:
  - IDOT BDE and BLRS Manuals
  - National guidance and best practices (e.g., NACTO Urban Street Design Guide)
- > Effective Illinois Examples:
  - City of Macomb Comprehensive Plan featured innovative design guidelines for pedestrian crossings and corridor enhancements

# Key Focus Area: Micromobility

- > Overview of personal micromobility devices and the growth of shared systems for bikes and e-scooters
- > Challenges and Opportunities: integration, safety, accessibility
- > Illinois examples:
  - Divvy bike share and other micromobility in Chicago
  - Expanding shared micromobility in suburban communities and small towns

- Tailoring strategies and resources for Illinois' diverse urban-to-rural land use contexts
- > Additional case study and best practice research
- Continued refinement based on feedback from IDOT staff, MPOs, local partners, and other stakeholders
