December 2023 cases being entered, less than 10,000 remain. Running data to check and finalize. Contract rewrite for CIS on March 15. Kick-off in May with BIP because current CIS is down. Begin new crash reports January 1, 2026. Talked to law enforcement over the years since 2019 (last crash report update). Contacting next few weeks for bureaus. 2 CIS consultants help maintain. If really need change and CIS cannot support, cannot maybe support to later add in values (in January Gen X=value change).

Currently working on annual reports and HPMS submittal; interstate HPMS data submitted yesterday [April 15]. iRoads now updated with the new urban areas boundaries approved by FHWA, based on 2020 census.
