- Illinois State Bar Association (ISBA) Omnibus Bill: Larry Davis is drafting a comprehensive traffic-safety bill that includes input from Secretary of State. Nancy will circulate the draft when and if available.

### **5. Discussion on Impaired Driving Strategic Plan:**

- Strategic Plan Review: The group reviewed each focus area of the plan; discussing suggested changes to objectives/strategies/tactics
- The Illinois Impaired Driving Task Force unanimously approved the updated plan for submission with the FY26 Annual Grant Agreement to NHTSA.
