1. Call to Order:

The meeting was called to order by Chair Nancy Easum.

2. Introductions:

 Members and attendees introduced themselves, highlighting their roles and affiliations.

3. Approval of Minutes from December 6, 2024 Meeting:

 Minutes were discussed but not formally approved due to issues in accessing them. Approval was deferred to the next meeting.

4. Legislative Updates:

- Judge Mark Shaner: Shared updates on the proposed legislation for DUI Courts. Key points included:
 - Adding exclusions for eligibility (e.g., offenses involving great bodily harm or school zones).
 - Suggestions to strengthen definitions for impaired driving beyond alcohol.
 - Revisions to align treatment court policies with traffic safety considerations.
- Collaboration with Jennifer Cifaldi and Desiree discussed. Further input pending from stakeholders.

5. Discussion on DUI Court Tracking:

 Members debated the necessity of a system to track post-program outcomes for participants in DUI courts, ensuring data-driven assessments of recidivism and program effectiveness.

6. Additional Legislative Proposals:

Rita Kreslin updated on outreach to legislators regarding task force proposals. Limited receptivity was noted, with future efforts planned postholiday season.

 Rita Kreslin inquired about tracking mechanisms for specialty courts across Illinois. Dan Hunt provided insights on certification and data reporting processes.

- Members agreed to refine legislative proposals and coordinate further stakeholder feedback.
- Mark Shaner to finalize suggestions for Senator Rose.
- Brenda Glahn to review and provide additional input on the draft DUI Court legislation.
