1. Call to Order

Chairwoman Nancy Easum called the meeting to order.

2. Introductions

All attendees introduced themselves.

3. Approval of Task Force Non-Voting Membership

Chairwoman Nancy Easum introduced a motion to nominate and approve Lindsay Simpson of the Northeastern Illinois Regional Crime Lab (NIRCL) for task force

4. Approval of Previous Meeting Minutes

The minutes for the November 2023 and January 2024 meetings were approved as written.

5. Discussion on Draft Legislation for Illinois DUI Statutes

Proposed Changes to 625 ILCS 5/11-501.2:

Jen Cifaldi shared proposed language that has already been approved by the task force. Discussion ensued over the various types of THC that should be included in the statute. Rita is checking the minutes on the exact language that was approved by the task force in a previous meeting.

6. Proposals by State's Attorney Pat Kinneally

Pat Kinneally discussed his proposals, which the task force reviewed and approved with changes recommended in previous meetings.

Bill Blundell (AOIC) and Nicole Sanders (ILCC) abstained from the votes.

The precise proposed language of the proposals is with Rita Kreslin.

The Obstructing Justice proposal approved is the one proposed by AAIM.

7. Legislative Proposals from ASA Christine Vukmir of Will County

Brenda Glahn proposed a slight amendment to the change to 730 ILCS 5/5-8A-3, which was approved. The proposal regarding time served for DUI offenders was approved. The proposal to introduce body cam photos and videos into evidence in a DUI case was amended to include booking photos and was approved.

8. Next Steps

Nancy Easum explained that sponsors will need to be identified for each piece of legislation. MADD and AAIM will discuss possible ways forward, with actions expected in the next spring legislative session.

9. Current Legislation Updates

Shannon Alderman discussed current legislation in the General Assembly regarding section a(7) in 11.501. Extensive discussion centered around the definitions and types of THC to include, as well as the testing methods for cannabis cases.

10. Subcommittee Reports

Nancy Easum asked for any reports from subcommittees; there were none.
