#### 2. Legislation Update

Presenter: Shannon Alderman

- Key Points:
  - Cannabis Per Se Law: Updates to clarify the 2-hour time limit for cannabis DUI enforcement.
  - Obstructing Justice: Proposals to enhance law enforcement's ability when suspects refuse to comply with DUI-related search warrants.
  - DUI Home Detention: Discussion on modifying language around DUI home detention.
  - Problem-Solving Courts: Proposal to officially recognize DUI courts as problem-solving courts in Illinois.
- Action Items:
  - IDOT to submit the cannabis per se law and obstructing justice proposals to the Governor's Office.

#### 3. Midwest Traffic Safety Conference

Presenter: Jennifer Cifaldi

- Conference Highlights:
  - Focus on prosecutor training, officer wellness, impaired driving enforcement, and more.
  - Efforts to increase registration for the event, targeting over 200 participants.
- Action Items:
  - Task force members encouraged to promote the event within their networks.

### 4. Toxicology Summit

Presenters: Jennifer Cifaldi and Lindsay Simpson

- Overview:
  - Summit designed to address challenges faced by law enforcement and prosecutors, particularly regarding laboratory testing in DUI cases.
  - Breakout sessions planned to foster discussions on synchronizing testing expectations across different toxicology labs.
- Action Items:
  - Continued work on finalizing the agenda for the Toxicology Summit.

#### 5. Task Force Membership and Voting

Presenter: Rita Kreslin

- Discussion:
  - Clarification needed on the membership structure, voting rights, and how to handle guest participation.
  - Plan to update and streamline the contact list, ensuring accurate representation from various agencies.
  - Introduction of a proposal to create a dedicated webpage on the IDOT site for easier access to meeting links, minutes, and task force documents.
- Action Items:
  - Rita to send a document to members for updating contact and voting information.
  - Shannon will take lead on this items and present to full task force for approval.
